# 2015 Montana Legislature REPORT & VOTING RECORD



This voting record summarizes how Representatives and Senators at the 2015 Montana Legislature voted on Montana Audubon's primary issues: wildlife and wildlife program funding, climate change and energy, and water quality. Please take the time to find out how your representatives voted. If your legislators voted for conservation, wildlife, and good environmental policies, thank them with a call or email. On the other hand, if they voted against Audubon on these issues, it is important to let them hear your concerns. Please share this voting record with others who might be interested and remember to consider it when you vote!

## Report on the 2015 Montana Legislature



Audubon kept busy during the 2015 Montana Legislature. In all, we testified on 68 bills, opposing 24 and supporting 44. Of these, our efforts helped defeat 10 anti-environmental/anti-wildlife bills, while 7 bad bills passed, and 7 were vetoed by the Governor. We helped pass 20 bills aimed at strengthening our environmental or wildlife laws, while 24 positive bills died.

So how did Audubon's issues fare at the 2015 Legislature?

Wildlife and wildlife program funding issues kept us busiest. Audubon worked hard to ensure that programs and laws adequately protect native wildlife and their habitats, from fish to birds, big game animals to predators. Our biggest effort this session was moving the Sage-Grouse Stewardship Act, SB 261, from a bill draft to being signed by the Governor. Now in place, the state of Montana can move forward to create a strong state-based sage-grouse conservation program. There were fewer attacks on bison and predators than past legislative sessions; however, the Governor vetoed two very bad bills impacting these species (Senate Bills 284 and 334).

One piece of good news for wildlife is that the new fishing and hunting licence fee bill passed, securing key funding for MT Fish, Wildlife, and Parks (FWP) into the future. This funding will help FWP contine long-term management programs for all of Montana's species. It took

concerted efforts to pass this bill through the legislature. In the end, lobbying efforts by many partners kept assualts on wildlife at bay.

Climate change and energy issues also received a lot of attention. Audubon considers renewable energy policy as an important oportunity to move Montana forward in the face of climate change. In the end, the Legislature changed little in terms of net-metering, community solar, coal-fired power, and renewable energy.

Our remaining efforts were spent on other environmental protection issues, especially water quality. In this category most bills that weakened environmental regulations were defeated or vetoed by the Governor. Although a few bills increasing environmental protections passed, unfortunately, a few bills detrimental to Montana's water quality passed.

#### Thank You!

Since 1981, Montana Audubon has lobbied during our state's Legislature. This year lobbyist Amy Seaman was ably aided by intern Jill Feldhusen, contractor Jake Troyer, and Director of Climate Policy Amy Cilimburg. While Jill kept Amy organized, helped with testimony, and helped keep our 'Action Alert' email program on track, Amy and Jake did a lot of research, testimony, and lobbying. We would like to thank everyone who helped us during the session, from generous donors, to citizens participating in our alert program, to citizens contacting legislators on specific bills, to members who participated in one or more lobby day. # Bill Descriptions - House of Representatives

Wildlife and Wildlife Program Funding

SB 261: Sage-grouse Stewardship Act

Sponsor: Senator Bradley Hamlett (D-Cascade)

Audubon Position: Support

Status: Passed House and Senate; Signed into law

**Description:** SB 261 formally created the Montana Sagegrouse Oversite Team, and further provided a frame-

work to enact Montana's sage-grouse conservation plan to maintain Sage-grouse populations on public and private land. Featured here is the House 2<sup>nd</sup> Reading vote; it passed 78 - 22. A vote *for* this bill is a vote *for* Audubon's position.



SB 284: County Commissioners' Authority over Bison

Sponsor: Senator John Brendon (R - Scobey)

Audubon Position: Oppose

**Status:** Passed House and Senate; VETOED by Governor **Description:** This bill required authorization by a board of county commissioners before wild bison are released. It would have required that the release of wild bison meet conditions of county growth policies. Similar bills were vetoed in 2013 and 2011. Featured here is the House 2<sup>nd</sup> Reading vote; it passed 60 - 40. A vote *against* this bill is a vote *for* Audubon's position.

#### HB 140: Revise Hunting and Fishing License fees

Sponsor: Rep. Jeffrey Welborn (R-Dillon)

Audubon Position: Support

Status: Passed House and Senate; Signed into law

**Description:** This bill revised and streamlined FWP license fees and licensing structure. There was a basic \$3 increase in fishing and \$8 increase in hunting licenses for residents. This bill was critical to ensure funding of FWP game and non-game programs for the next four years. Featured here is the House 2<sup>nd</sup> Reading vote; it passed 71 - 29. A vote *for* this bill is a vote *for* Audubon's position.

#### SB 334: Revise Wildlife Definitions

Sponsor: Senator Jennifer Fielder (R-Thompson Falls)

Audubon Position: Oppose

Status: Passed House and Senate; VETOED by Governor Description: SB 334 would have revised the definition of game animal to include game birds, migratory game

birds, and furbearers, while defining badgers, raccoons, and red fox as predatory animals. These changes would have legalized the use of calls and trapping of these new predators; the new definitions also unintentionally created management challenges for FWP. The vote featured here is the House 2<sup>nd</sup> Reading vote; it passed 53 - 47. A vote *against* this bill is a vote *for* Audubon's position.

#### Climate Change and Energy

SB 114: Classify All Hydro Facilities as Renewable

Sponsor: Senator Debbie Barret (R-Dillon)

Audubon Position: Oppose

Status: Passed House and Senate; VETOED by Governor Description: This bill would have eviscerated Montana's Renewable Energy Standard by allowing all water power from existing commercial dams to be counted towards the standard, eliminating incentives for the production of new renewable resources such as wind and solar. Similar bills were vetoed in 2013 and 2011. The vote featured here is the House 2<sup>nd</sup> Reading vote; it passed 57 - 43. A vote *against* this bill is a vote *for* Audubon's position.

#### HJ 11: Joint Resolution Supporting Keystone Pipeline

Sponsor: Rep. Mike Lang (R-Malta)

Audubon Position: Oppose

Status: Passed House and Senate

**Description:** This joint resolution called for prompt Congressional and Presidential approval of the Keyston XL Pipeline. The pipeline would have major consequences for Montana's wildlife, and would add 1.44 million metric tons of carbon dioxide into the atmosphere each year of use. The vote featured here is the House 2<sup>nd</sup> Reading vote; it passed 72 - 28. A vote *against* this bill is a vote *for* Audubon's position.

#### SJ 13: Joint Resolution Supporting Coal

Sponsor: Senator Duane Ankney (R-Colstrip)

Audubon Position: Oppose Status: Passed House and Senate

Description: This resolution supports the continued development of coal as a primary energy source in Montana. Coal is a major contributor to climate change and renewable energy is increasingly becoming cheaper than coal-produced energy. The vote featured here is the House 2<sup>nd</sup> Reading vote; it passed 73 - 27. A vote *against* this bill is a vote *for* Audubon's position.

### SB 402: Revise Utility and Coal-fired Generation Laws

Sponsor: Sen. Duane Ankney (R-Colstrip)

Audubon Position: Oppose Status: Failed in the House

Description: This bill would have penalized out-of-state utilities that own part of Colstrip's coal-fired power plants if the plants close by 1) fining them hundreds of millions of dollars per year for forty years and 2) making them responsible for cleanup costs for other Colstrip owners. This bill would have sent a message to Montana businesses that the Montana Legislature bails out unprofitable busineesses (bad public policy). The vote featured here is the House 2<sup>nd</sup> Reading vote; it failed 43 - 57. A vote *against* this bill is a vote *for* Audubon's position.

#### Water Quality

#### SB 160: Change Water Quality Standards

Sponsor: Senator Duane Ankney (R-Colstrip)

Audubon Position: Oppose

**Status:** Passed House and Senate; VETOED by Governor **Description:** This bill would have included human-caused pollution in the 'natural' condition of a stream, so that waste water produced by energy companies would be permissible. This would have violated the federal Clean Water Act and threatened water quality. The vote featured here is the House 2<sup>nd</sup> Reading vote; it passed 58 - 42. A vote *against* this bill is a vote *for* Audubon's position.

#### SB 325: Revise Water Quality Regulation Process

Sponsor: Senator Jim Keane (D-Butte)

Audubon Position: Oppose

Status: Passed House and Senate; Signed into Law Description: This bill will weaken water quality standards and remove protections for downstream water users, such as irrigators. It will also prohibit the state from establishing site-specific water standards to protect water quality and water users. Additionally, the

bill muddied the definition of a natural stream and may have made it impossible for the state to adopt water quality standards more strict than federal law. The vote featured here is House 2<sup>nd</sup> Reading; it passed 62 - 38. A vote *against* this bill is a vote *for* Audubon's position.

#### Public Lands and Land Management

#### HJ 19: Resolution Against Transfer of Federal Lands

Sponsor: Rep. Ed Lieser (D-Whitefish)

Audubon Position: Support

Status: Failed during House blast motion\*

Description: This resolution would have reaffirmed the State of Montana's opposition to taking over, selling off, or litigating for control of federal public lands in Montana. Public lands are vital to Montana's economy, recreation, heritage, and quality of life; public land transfers have little public support. The vote featured here is the House blast motion; it failed 44 - 54. A vote for this bill is a vote for Audubon's position.

#### HB 496: Establish Public Lands Task Force

Sponsor: Rep. Kerry White (R-Bozeman)

Status: Passed House and Senate; VETOED by Governor

Audubon Position: Oppose

**Description:** This bill would have established a task force to study the feasibility of state management of public lands in Montana. Taxpayers in Montana have already paid for a very similar study; we do not support legislation aimed at transferring federal land to the state. The vote featured here is the House 2<sup>nd</sup> Reading vote; it passed 51 - 49. A vote *against* this bill is a vote *for* Audubon's position.

#### HB 182: Require Zoning Before Regulating Land Uses

Sponsor: Rep. Forrest Mandeville (R-Columbus)

**Status:** Failed in the House

**Description:** This bill prohibits a governing body from considering how land proposed to be subdivided will be used unless the land is zoned. This would have severly weakened local government's ability to consider impacts on water, wildlife, agricultural lands, local services and public health and saftey in un-zoned areas during the subdivision review process. The vote featured here is the House 2<sup>nd</sup> Reading vote; it failed 59 - 41. A vote *against* this bill is a vote *for* Audubon's position.

## **Bill Descriptions - Senate**

#### Wildlife and Wildlife Program Funding

SB 261: Sage-grouse Stewardship Act

Sponsor: Senator Bradley Hamlett (D-Cascade)

Audubon Position: Support

**Status:** Passed House and Senate, Signed by Governor **Description:** SB 261 is described in the House Voting Record. Featured here is the Senate 2<sup>nd</sup> Reading vote; it passed 42 - 8. A vote *for* the bill is a vote *for* Audubon's position.

SB 247: Prohibit Sage-grouse Hunting in Montana

Sponsor: Senator John Brendon (R-Scobey)

Audubon Position: Oppose

Status: Defeated in House committee

**Description:** This bill would have prohibited all sagegrouse hunting in Montana. It did not address science-based reasons behind the sage-grouse population decline. The Fish and Wildlife commission should regulate the hunting of game animals. Featured here is the Senate 2<sup>nd</sup> Reading vote; it passed 38 - 12. A vote against this bill is a vote for Audubon's position

#### SB 284: County Commissioners Authority over Bison

**Sponsor:** Senator John Brendon (R - Scobey)

Audubon Position: Oppose

**Status:** Passed House and Senate, VETOED by Governor **Description:** SB 284 is described in the House Voting Record. Featured here is the Senate 2<sup>nd</sup> Reading vote; it passed 33 - 17. A vote *against* the bill is a vote *for* Audubon's position.

# SB 21: Provide for Mandatory Penalty for Misuse of Replacment Fish and Game Licenses

Sponsor: Senator Jill Cohenour (R-Huntley)

Audubon Position: Support

Status: Passed House and Senate; Signed into law

**Description:** This bill increases the penalty on individuals who knowingly purchase and use a replacement hunting license. This is an increasingly expensive problem for FWP; and a steeper penalty could deter this behavior. The vote featured here is the Senate 2<sup>nd</sup> Reading vote; it passed 30 - 20. A vote *for* this bill is a vote *for* Audubon's position.

#### SB 334: Revise Wildlife Definitions

Sponsor: Senator Jennifer Fielder (R-Thompson Falls)

Audubon Position: Oppose

**Status:** Passed House and Senate; VETOED by Governor **Description:** SB 334 is described in the House Voting

Record. The vote featured here is the Senate 2<sup>nd</sup> Reading vote; it passed 31 - 18. A vote *against* this bill is a vote *for* Audubon's position.

#### SB 114: Classify All Hydro Facilities as Renewable

SB 172: Revise Groundwater Testing Requirement

Sponsor: Senator Sharon Stewart-Peregoy (D-)

Status: Failed in the Senate blast motion\*

**Description:** This bill would have provided land and mineral owners within one mile of a proposed oil or gas well the ability to have groundwater tested by a third party before and after development. The drilling applicant would be responsible for the costs. Featured here is a Senate blast motion vote; it failed

HB 496: Establish Public Lands Task Force
